Here's a tip from the <u>Source Citations</u> for <u>Successful People</u> course:

A good source citation will tell you the answers to these questions:

- 1. Who Who is the source referring to?
- 2. What- What does the source document?
- 3. When When was the event, and when was the source created?
- 4. Where Where is the source located (repository)
- 5. Where Where did you access it? (On Ancestry.com, online, at the library, etc.)



# Why Cite Sources?

- 1. To document your research
- 2. Lend credibility to your work
- 3. Support theories, assertions, or proof statements
- 4. Show reliability of sources



## **Citation Examples**

Here are some idealized example citations as they might appear in the *Sources* field of a *Family Group Record* printed using the Personal Ancestral File (PAF) program. These footnotes mostly follow the *Chicago Manual of Style*. Following the first citation in each category there is a list of the fields used in the PAF *Edit Source* and *Sources*— *Citation Detail* windows to create that source footnote. All footnotes in this list are only models—other researchers may choose different ways to render the same footnote information.
